submitted. The Temple-Greenville Police Department only submitted a budget. The Town would speak to Temple about a written report next year. The Article was amended by Mr. DeWinter and seconded by Richard Eaton and voted in the affirmative to accept reports of auditors, Agents and Committees as corrected and submitted in the annual Town Report.

The town treasurer shall have custody of all moneys in the fund, and shall pay out the same only upon order of the selectmen and no further approval is required by the legislative body to expend. Such funds may be expended only for the purpose for which the fund was created. And to raise and appropriate the sum of Five thousand dollars (\$5,000) to be added to this fund, said funds to come from general fund unreserved fund balance. If the Temple Joint Police Department is dissolved, the \$5000 used as start up money for this fund will be returned to the newly formed Greenville Police Budget

Motion made by Leon Proctor and seconded by Mrs. Washburn and voted in the affirmative to create an Expendable Trust Fund under the provisions of RSA 31:19-a, to be known as the Water Department Fund, for the purpose of purchasing, repairing, and maintenance of all water treatment plant equipment, to include the lagoons, water storage tanks, distribution system, to repair and maintain all water treatment buildings, and for engineering, consulting cost, testing and inspections, and to raise and appropriate the sum of Two hundred fifteen thousand one hundred thirty-six dollars (\$215,136) with One hundred sixty-five thousand one hundred thirty-six dollars (\$165,136) to come from general fund balance and the balance of Fifty thousand dollars (\$50,000) to come from water unreserved fund balance and to further authorize the Selectmen as agents to expend.**

**Article 8. Motion made by Mr. C. Buttrick and seconded by Steve Spratt and voted in the affirmative to create an Expendable Trust Fund under the provisions of RSA 31:19-a, to be known as the Wastewater Department Fund, for the purpose of purchasing, repairing, and maintenance of all wastewater treatment plant equipment, to include the pump stations, collection system, repair and maintenance of wastewater treatment buildings and for engineering, consulting costs, testing and inspections, and to raise and appropriate the sum of Fifty-four thousand eight hundred twenty-five dollars (\$54,825) with Thirty-four thousand eight hundred twenty-five dollars (\$34,825) to come from general fund unreserved fund balance and the balance of Twenty thousand dollars (\$20,000) to come from taxation and to further authorize the Selectmen as agents to expend.**

**Article 10.** Motion made by Mr. Spratt and seconded by Mr. Hartley and voted in the affirmative to establish a new Expendable Trust Fund under the provisions of RSA 31:19-a, to be known as the Wastewater Treatment Plant Upgrade Replace Fund for the purpose of all cost associated with the upgrading or replacement of the wastewater treatment plant and to raise and appropriate the sum of One hundred thirty thousand five hundred ninety dollars (\$130,590) for this fund and to authorize the Board of Selectmen as agents to expend, funds to come from surplus and no amount to be raised by taxation.

Buttrick and seconded by Mrs. Washburn and voted in the affirmative to raise and appropriate the sum of Two thousand six hundred twenty-five dollars (\$2,625) to be added to the Pool Repair/Improvement Expendable Trust fund and to authorize the use of the 2008 fund balance for this purpose.

**Article 14.** Motion made by Deb Bouley and seconded by Mr. Blease and voted in the affirmative to raise and appropriate the sum of Two thousand eight hundred dollars (\$2,800) for repairing of the walkway to the town clerk's office and library and to authorize the withdrawal of Two thousand eight hundred dollars (\$2,800) from the Sidewalk and Related Equipment Capital Reserve Fund created for that purpose.

**Article 15.** Motion made by Mrs. Washburn and seconded by Mrs. Bergeron and voted in the affirmative to abolish the Recreation Revolving fund as established in 1999 with said funds with accumulated interest to date of withdrawal, to be transferred to the general fund.

**Article 16.** Moved and acted upon.

**Article 17.** Motion made by Mr. Fedders and seconded by Mr. Blease and voted in the affirmative to raise and appropriate the sum of Fifty thousand dollars (\$50,000) for the town's 25% share of all cost associated with the ice storm of December 2008.

Kathleen Washburn was presented flowers for service as selectman for one year

Mrs. Louise Mc Cuddy was presented with a plaque in her husband's name, James McCuddy for his service as selectman, and his years of community service.

# **SPECIAL AMERICAN RECOVERY AND REINVESTMENT ACT OF 2009 (ARRA) TOWN MEETING SEPTEMBER 12, 2009 SYNOPSIS**

Meeting began at 9:00 am. The moderator, Mr. James Lambert lead us in the pledge of allegiance to the flag.

## **Article1:**

Motion made by Mr. Eaton and seconded by Mr. Charles Buttrick and voted in the affirmative by a ballot vote (28 yes 2 no) the required 2/3<sup>rd</sup> needed to raise and appropriate the sum of Eight Hundred Seventy-Five Thousand Dollars (\$875,000.00) for the design, permitting, and construction of two (2) new secondary clarifiers at the existing Wastewater Treatment facility to help the town comply with the limits required by the towns NPDES permit and to authorize the issuance of not more than Eight Hundred Seventy-Five Thousand Dollars (\$875,000.00) in State Revolving Fund loans in accordance with the provisions of the Municipal Finance Act and to authorize the Selectmen to issue, negotiate such State Revolving Fund loans and to determine the rate of interest thereon; furthermore, to authorize the acceptance of grants under the American Recovery and Reinvestment Act of 2009 in the amount of fifty percent (50%) of the eligible project cost. This appropriation is contingent upon receipt of the American Recovery and Reinvestment Act of 2009 Federal Stimulus Funding. \*(By way of explanation, and without impairing the fact that the legal obligation for the repayment of the within contemplated bond is intended to be a general obligation of the Town of Greenville, the Selectmen contemplate passing as much as 50% of the debt service associated with this article on to the wastewater users in the form of rates, assuming and to the extent that this can legally be accomplished.)

## **Article2:**

Motion made by Mr. Eaton and seconded by Mr. Marshall Buttrick and voted in the affirmative by ballot vote (22 yes 7 no) the required 2/3<sup>rd</sup> needed to raise and appropriate the sum of One Hundred Twenty-Five Thousand Dollars (\$125,000.00) for the design, permitting, bidding and installation of an automatic read replacement water meter system (including billing) for all current water services in the Town and to authorize the issuance of not more than One Hundred Twenty-Five Thousand Dollars (\$125,000.00) in State Revolving Fund loans in accordance with the provisions of the Municipal Finance Act and to authorize the Selectmen to issue, negotiate such State Revolving Fund loans and to determine the rate of interest thereon; furthermore, to authorize the acceptance of principal forgiveness under the American Recovery and Reinvestment Act of 2009 in the amount of fifty percent (50%)



of the eligible project cost. It is intended that the debt service is to be paid entirely from the Water Expendable Trust Fund and not from the General Fund. This appropriation is contingent upon receipt of the American Recovery and Reinvestment Act of 2009 Federal Stimulus Funding.

The meeting was adjourned at 11:45 AM.

**Article 14.** To see if the Town will vote to authorize the Board of Selectmen, in accordance with RSA 41:14-a, to accept the donation of land located at Map 2, Lot 37 (2.105 acres recorded in the Hillsboro County Registry of Deeds, Ref: Bk-Pg 3666711:01) according to such terms and conditions as the Board deems appropriate and reasonable, for the purpose of building a new fire station.

**Recommended by the Board of Selectmen**

**Article 15.** To see if the Town will vote to raise and appropriate a sum not to exceed Ninety-two thousand dollars (\$92,000) to conduct a geo-technical study, survey, prepare architectural plans and drawings, engineering and conduct site work for a new fire station and further to authorize the Selectmen to withdraw up to Ninety-two thousand dollars from the New Fire Station Expendable Trust Fund.

**Recommended by the Board of Selectmen**

**Article 16.** To see if the Town will vote to raise and appropriate the sum of Forty-two thousand forty dollars (\$42,040) to purchase and equip a new police cruiser with Sixteen thousand dollars (\$16,000) coming from the Town of Temple and Twenty-six thousand forty dollars (\$26,040) coming from the Greenville Police Cruiser Expendable Trust Fund.

**Recommended by the Board of Selectmen**

**Article 17** **By Petition.** To see if the Town will vote to approve the following resolution to be forwarded to our State Representative(s), our State Senator, the Speaker of the House, and the Senate President.

**Resolved:** The citizens of New Hampshire should be allowed to vote on an amendment to the New Hampshire Constitution that defines "marriage".

## **BOARD OF SELECTMEN**

2009 has been a very challenging year for the Board of Selectmen. The remnants of the 2008 Ice Storm has consumed many hours of hard labor and administrative work. In November of this year, the Town closed Richardson Road due to flood damage and lack of funds. Repair to White Street was completed this year which should resolve the ongoing flooding issues. A special thank you to Marcel Bernier for helping the Highway Department complete Grant applications.

The withdrawal of Mason from the district had a significant impact to the tax rate. Major concerns for the Board this year which will continue into the future is the instability of the State deficit. Most towns are very dependent upon these funds to help subsidize their local budgets in the form of Highway Block Grant, Room and Meal Tax, Shared Revenue, and Water Pollution Grant.

Numerous discussions with the DES and DRA occurred this year in order to be eligible for ARRA funding. Special Town Meetings were held within the allotted time to qualify for funding. The Town must comply with DES requirements for the Wastewater Treatment Plant. All phases of upgrades to the Wastewater Plant must be completed by the year 2013. Also the Town was notified that more funding became available for water projects. The Town applied for a Radio Read Metering System which allows for identifying leaks in a timely manner to minimize and conserve loss of water.

The Board of Selectmen would like to give special thanks to Elisa FitzGerald for all the hard work she has done this year and her dedication to the Town. We all owe her a great deal of gratitude. We would like to thank Maureen Gauvin for her efforts on numerous projects during this year. Please join us in welcoming Kelley Collins as our Town Administrator, she brings a wealth of Municipal and administrative experience to our community. As always we appreciate the participation of all residents, volunteers, employees, department heads, and committee members.

As taxpayers, this Board has struggled all year under trying circumstances to balance the needs of all residents against a lack of funding, loss of revenues, old and new projects, continued litigations, personnel issues, and various other matters.

Our goal in 2010 will be to continue to oversee all financial business and to be cost effective and proactive in governing our town.

You can now register your renewals online at "[greenvillenh.org](http://greenvillenh.org)" and click on "online vehicle registration renewal" The site will not take credit cards at this time, but does take checks. You will need your checking account information and your bank routing number. The online system has worked very well giving the residents another way to renew their vehicles.

The State is now in the beginning stages of changing the way we apply for titles, bringing it up to date with the new registrations. Many states are doing electronic titles, eliminating some of the paper work involved. It will again be another learning curve.

You can also apply for your Drivers License renewal online starting with renewals for February 2010. Motor Vehicles also has forms that you are able to print such as applications for a duplicate title, to check availability of vanity plates, applications for copies of registrations, verification of vin number forms and many others.

Thank you to Deb Reardon and Bernadette Desmarais for the responsible way you continue to do such a great job.

## **HUMAN SERVICES DEPARTMENT**

The goal of any Town Welfare Department is to balance the requirements of RSA 165:1, which states in part "Whenever a person in any town is poor and unable to support himself, he shall be relieved and maintained by the overseers of public welfare of such town, whether or not he has residence there."

There are also requirements that protect the tax payers from being the only source of relief like RSA 165:19 which states, in part: "The relation of any poor person in the line of father, mother, stepfather, stepmother, son, daughter, husband, or wife shall assist or maintain such person when in need of relief" and RSA 165:28 which states, in part: "The amount of money spent by a town or city to support an assisted person under this chapter shall, except for just cause, be made a lien on any real estate owned by the assisted person."

As everyone knows, the downturn in the economy has had a huge impact on personal finances. People who were once self-sufficient now find themselves turning to the Town for assistance.

In 2009 the department spent approximately \$35,000 on direct aid to the needy. Rent accounted for 78% of the aid, electric was 9%, heat was 7%, food was 3% and medical needs accounted for 3%. It is the Town's mission to assist people in a confidential, dignified manner with an aim towards self-sufficiency.

The Town wants to thank all the Human Service Agencies that we refer our local clients to such as: The River Center in Peterborough as well as our local churches for their support of those in need.

Based on 2009 numbers, as this report goes to print in early 2010, we are anticipating 2010 will be a tough year for the welfare budget. We will do everything we can to be proactive and cost effective with the Town's welfare dollars.

## **TEMPLE-GREENVILLE POLICE DEPARTMENT**

In 2009 we had a decrease in the number of motor vehicle incidents and arrests due to our patrol efforts. Because of our speed enforcement patrols, the officers have observed motorists driving more slowly, which results in fewer accidents. Our DWI cases were also down; however, we did see an increase in our disorderly conduct cases.

The addition of part-time officer Rick Sprankle, a twenty-four year veteran of the Nashua PD, and the drug enforcement expertise of Sgt. Richard D'Auria, a twenty-two year veteran of the NH State Police, has enabled us to solve our burglaries. The fact is that the majority of burglaries are drug related. We have solved thirteen burglaries in Temple, Greenville, and neighboring towns. Six individuals are incarcerated awaiting trial for those burglaries. Our other drug related arrests included stopping a professional marijuana growing operation.

We begin the year of 2010 with the continued commitment to do our best. The Temple-Greenville Police Department has the 'best of the best' police officers. Our officers have a combined total of over 150 years of training and experience in law enforcement. The joint board and I have worked hard each and every month to keep costs down and provide excellent service to our citizens. I thank all of you for your support.

## FOREST FIRE WARDEN AND STATE FOREST RANGER

Your local Forest Fire Warden, Fire Department, and the State of New Hampshire Division of Forest & Lands work collaboratively to reduce the risk and frequency of wildlands fires in New Hampshire. To help us assist you, please contact your local Forest Fire Warden or Fire Department to determine if a permit is required before doing ANY outside burning. Under State law (RSA 227-L:17) a fire permit is required for all outside burning unless the ground is completely covered with snow. The New Hampshire Department of Environmental Services also prohibits the open burning of household waste. Citizens are encouraged to contact the local fire department or DES at 1-800-498-6868 or [www.des.state.nh.us](http://www.des.state.nh.us) for more information. Safe open burning requires diligence and responsibility. Help us to protect New Hampshire's forest resources. For more information please contact the Division of Forests & Land at (603) 271-2214, or online at [www.nhdfi.org](http://www.nhdfi.org).

Spring fire season was unusually short this past year, with wet weather beginning the third week in April and lasting virtually all summer long. Consequently, both the number of fires and the number of acres burned were below the last five year average. Due to state budget constraints, the staffing of our statewide system of 16 fire lookout towers was limited to class III or higher fire danger days. Despite the reduction in the number of days staffed, our fire lookout towers are credited with keeping most fires small and saving several structures this season due to their quick and accurate spotting capabilities. The towers fire spotting capability was supplemented this year by contracted aircraft and the Civil Air Patrol when fire danger was especially high. Surprisingly, the largest single fire this year occurred in late November during an unusual dry spell, in the northern Coos County Town of Clarksville. This fire burned 17.1 acres and is presumed to have been caused by a careless hunter. Many homes in New Hampshire are located in the wildland urban interface, which is the area where homes and flammable wildland fuels intermix. Several of the fires during the 2008 season threatened structures, a constant reminder that the forest fires burn more than just trees. Homeowners should take measures to prevent a wildland fire from spreading to their home. Precautions include keeping your roof and gutters clear of leaves and pine needles, and maintaining adequate green space around your home free of flammable materials. **We have been working on our Hazard Mitigation projects starting with White Street. The plastic culvert has been replaced with a bigger cement culvert which should last a hundred years.**

**The office also has a new ham radio in which a ham operator can contact Concord Emergency Management Office and other towns during an emergency. Both myself and Deputy Johnson will be Licensed Operators by the end of 2010 to operate the radio.**

**Deputy Johnson has also completed Incident Command 300 this year, and will be helpful for this office. We continue to prepare the departments and community to be prepared for an emergency situation and to be here to assist at anytime we are needed. The only two concerns we have is #1 have the extra money to complete the grant process, and #2 generators for our two shelters. We hope to keep moving forward with these projects but we have no budget for either at this point.**

**Thanks to all departments, Selectmen's Office, New Ipswich Emergency Management, and New Hampshire Emergency Management Office for all their help throughout the year because without these people we could not do the job.**

## **RECREATION & PARKS**

The Recreation & Parks Committee had yet another good year, maintaining and improving our facilities with an emphasis towards saving money. For the third year, we have reduced our budget. However, we continue to expand our activities, enabling more town residents to use our facilities.

We would like to thank two long-term employees for their dedicated service. Keri Poirier and Christine McInnis are moving on to full-time work, after serving as our pool directors this past season. We wish them the very best.

We would like to list our activities for this past year:

- Ice skating rink - While still a work in process this third year, we hope more people make use of the rink. Thanks to the Highway Department for their help.
- Mascenic Promising Practices – We exhibited at this event once again.
- Fishing Derby – The Derby was yet again a huge success.
- Walking Track – It is gratifying to see the track used so much. Keep walking!
- Walk NH – We participated in this statewide event for the second year, using the above-mentioned track.
- Free Films – We cooperated with the Library to offer free movies in the Town Hall Meeting Room. The participation is growing.
- Octoberfest – We re-instituted this event at Ida Taft Park and had good participation, considering the poor weather.
- Mill Pond Park – It is great to see the park being enjoyed so much, both by picnickers and for fishing. Thanks to the Highway Dept. for all the work they have put in to maintain it.
- Pots & Pans Celebration – We once again participated in this well-know town event.
- Tennis & Basketball courts – We sealed all the cracks in an effort to maintain the courts and not had to re-pave them, yet. The ice storm damage to the fences was repaired at no cost to the town.

The town pool continues to be our focus. This past year saw a 33% increase in pool usage to just below the level of 2007. We were only closed six days in July/August. After a pressure test identified numerous leaks, we had two skimmers repaired and replaced all the skimmer lines, resulting in significant water and chemical savings. We replaced leaking filter tank valves, showerheads, locks and repaired the toilets. We also made our electrical outlets GFI

grounded. All this was done without dipping into the pool trust fund. For the first time ever, our swim team placed first in a swimming competition. We are very proud of them! The team also raised \$740 in their Swimathon to pay for their swimsuits. We continued to offer Water Aerobics. Our swim lessons brought in \$529 in revenue, while teaching more kids the fun of swimming.

We look forward to 2010. We are excited to know four of our lifeguards have already committed to return, giving us continuity in our swimming program.

We would like to thank Tony Zina for his numerous contributions to our committee. We desperately need another member. The more input we have, the better we will function. Please consider joining!

## **CONSERVATION COMMISSION**

The Conservation Commission reviewed two applications for wetlands permits. The first was for a new culvert on White Street and the second was for a culvert on Richardson Road.

Two of the trails in the Potter woods have been cleared of debris from the 2008 ice storm. There is one trail remaining to be cleared. We were able to host a walk on this property in October for the Nashua River Watershed Association.

The roadside cleanup was held as usual in the spring with assistance from the Scouts and from volunteers. By conducting a roadside clean-up we qualified for free flower bulbs from NH the Beautiful. The bulbs were given to the Beautification Committee for planting.

Water quality testing of the Souhegan River was conducted as in the past. The Souhegan River Watershed Association received a grant to develop protocols for locating and abating sources of pollution entering the river. FB Environmental Consulting located one source of pollution and is dealing with remediation.

## **CHAMBERLIN FREE PUBLIC LIBRARY**

2009 was the busiest year on record for Chamberlin Free Public Library. We circulated 16,822 items (an increase of 16%) and served 16,215 patrons (an increase of 26%). One hundred forty-two new patrons were issued library cards this year – an increase of 53% over last year. Interlibrary loans made to other libraries increased 33% to 703 while we requested 766 items for our patrons from other libraries (an increase of 55%). We added 1,066 new items to our collection, broken down as follows:

Adult Fiction Books -- 210  
Adult Nonfiction Books -- 41  
Young Adult Fiction Books 187  
Young Adult Nonfiction Books -- 63  
Children's Books -- 160  
Audio Books -- 24  
Large Print Books -- 59  
DVDs -- 322

This year, Chamberlin Free Public Library has concentrated on public outreach programming. Our vision is to be a center for Greenville's cultural life and community service and as a result, we presented a total of 142 programs serving 759 adults and 906 children during 2009.

Organized by Chamberlin librarians Diane Steele, Brenda Cassidy and Connie Cooke, Knit for a Cause is a group of knitters from Greenville and surrounding towns who meet weekly at the library to knit items using donated yarn which are in turn distributed to those in need. This group hand-knit comfort shawls which were sent to Merrimack Hospice, Pheasant Wood Nursing Home, Good Shepherd Nursing Home and Monadnock Community Hospital's adult, pediatric and maternity wards. Preemie caps were distributed to Monadnock Community Hospital and Elliot Hospital while scarves, hats, mittens, slippers and afghans were sent to St. Vincent DePaul.

The Adult Book Group continued to attract readers to the monthly book discussion. This group serves a dual function of literacy advancement and social networking while encouraging exposure to broader reading topics by offering literary selections and genres patrons might ordinarily not read.

In our continuing effort to partner with local education, second graders from Greenville Elementary School visit us every two weeks to supplement the materials available at their school library. Stories are read to these students by library staff in an effort to foster a love for

reading. We anticipate this program to be expanded to include pre-school students from Greenville Elementary.

Our weekly Story Hour and Craft program continued to be a popular venue for local preschoolers and home-schoolers. The librarians spent many hours preparing craft items for children to make while volunteer parents and librarians read stories to these children. These programs were attended by 423 children and parents.

To celebrate the International Year of Astronomy, Chamberlin Free Public Library presented an ongoing series of programs dedicated to the understanding and enjoyment of our universe. Patrons learned about our solar system, the galaxy and beyond and viewed some of these wonders through telescopes. Additionally, some of the patrons were loaned telescopes and binoculars to encourage their pursuit of the hobby.

Our popular AARP-staffed income tax preparation assistance continued this year. This program offered elderly and low-income taxpayers free help in completing and filing income tax forms. During the past tax year, thirty-six Greenville residents were served by this program

Our summer reading program, "Summertime and the Reading is Easy" attracted a total of 140 children over a period of five weeks. The highlights of the program were an appearance by musician and puppeteer Rick Goldin and a field day for the program participants.

Other community service programs offered at Chamberlin Library included an American Heart Association CPR Certification course; "Coming Together in a Time of Crisis", a support seminar for the unemployed and underemployed offered in conjunction with Catholic Charities; and a four-week course on Open Office productivity software to help residents learn necessary skills for today's job market,

The annual Greenville Tree Lighting took place in December and Chamberlin Library was the venue for the festivities. Refreshments were provided by the Holiday Committee. Nearly 100 adults and children were in attendance to meet Santa and to enjoy a bit of the holiday spirit.

This year, in conjunction with the Greenville Recreation Department and Movie Licensing USA, we have inaugurated a series of free, recently released movies for Greenville residents. With the loan of a multimedia projector and a generous donation of a premium sound system, we are able to show these movies onto a 100-inch screen in the Town Hall Meeting Room. We hope to expand our movie schedule

as resources and space become available.

Our web site received a major overhaul this past year. A new page format was adopted which makes navigating easier for the patron. Additionally, a new blog site for Chamberlin Free Public Library was developed which can be reached at [chamberlinfreelibrary.blogspot.com](http://chamberlinfreelibrary.blogspot.com) or by the link on our main web site [www.chamberlinlibrary.org](http://www.chamberlinlibrary.org). A total of 4,397 people visited our web site this year.

Our Greenville Town Reports Archive Project is nearly completed. We now have available most town reports through 1980 in Adobe PDF file format. We will conclude this project in 2010 and it will provide users with valuable genealogical data and town history. We have made these reports, as well as other historical documents relating to the town of Greenville, available to all interested parties at the library and our web site.

Donations of books and videos increased significantly this past year. These gifts have supplemented our media budget and have allowed us to reach an ever-growing group of young readers. A local retired teacher donated more than 500 children's paperback books. Others have donated paperback and hardcover books for general circulation and for our ongoing book sale. Again this year, a significant number of recently released DVDs were added to our holdings due to the continued donations from one of our patrons. This gift of several hundred more DVDs has helped to create a video collection that is truly exceptional and has resulted in our library circulating nearly 4,500 videos in 2009.

Chamberlin Free Public Library continued to host Community Channel 21 this year. In addition to the traditional message board format, we introduced a number of community service video presentations. Our first live broadcast of Candidate's Night allowed cable viewers the opportunity to see some of our candidates for local office being questioned on important local issues. We also aired a number of the SAU 87 School Board sessions dealing with the pressing issues facing our schools. We hope to expand this type of programming next year and to strengthen our ties with community groups and activities.

We would like to welcome our newest library trustee, Kathy Caron. She has graciously agreed to fill one of our vacancies and her experience will be a valuable addition to the Board of Trustees.

## **THE SOUHEGAN VALLEY AMBULANCE SERVICE, INC**

Souhegan Valley Ambulance Service (SVAS) responded to approximately 470 emergency calls in 2009. We have a very dedicated membership that spends countless hours ensuring the highest quality of care for our community. These hours not only include responses to emergency calls but also the many hours of training required to maintain medical licenses, maintain equipment, and complete the required day-to-day administrative tasks.

As we stated in last year's report we made the decision to hire per-diem personnel; this has certainly made for an interesting year as we continue to learn the different aspects of the administrative needs for our endeavor. Our goal was to start with covering our daytime shifts; we have met this goal and continue to work on what is best for the community with the assets we have.

We have managed to absorb most of the expected cost increase in our budget again this year, and we will do our best to defer an increase in costs to the towns we serve, but an increase to the town budgets in future years may be unavoidable. Our goal has been, and will continue to be, to provide the best possible care while keeping the cost as low as possible for the towns we serve.

The Board of Directors would like to extend its thanks to the community for its support of the ambulance service. We would also like to express our sincere appreciation to the members of SVAS and their families (who put up with the countless hours and interrupted lives). Thank you for your time and dedication.

## **WASTEWATER TREATMENT FACILITY & SYSTEMS**

In 2009, Woodard & Curran provided complete Operations and Maintenance of the Wastewater Treatment Facility, two pump stations, the collection system and the IPP & FOG programs as mandated by the NH DES. The Treatment Facility has continued to achieve a 96+% removals for both BOD (biochemical oxygen demand) and TSS (total suspended solids) on the effluent discharge to the river. We had 33 recordable NPDES permit exceedences for the year; this was due to the issuance of a new EPA NPDES permit that contained stricter limits on the effluent discharge into the river to include several metals, most notably phosphorous. These new limits were not included on previous permits dating back to 1974.

### **STAFFING**

The Wastewater Treatment Facility, collection system, pump stations and Industrial Pretreatment Program (IPP) are maintained and operated by the following staff.

Note: Additional personnel are utilized when needed and are supplied by Woodard & Curran at no additional cost to the Town.

### **ADMINISTRATIVE**

The Town is working on having a formal rate study done for both the water and wastewater treatment facilities. With due diligence and strengthen the partnership with the Town, Woodard and Curran has made an agreement with the Town to do this project free of charge. It has resulted in a \$10,000 savings and will help to modernize the current rate structuring system to better fund operating and capital expenditures.

### **OPERATION & MAINTENANCE**

Woodard & Curran has an extensive support network that allows for expert assistance to address facility problems that may extend past the normal operator level of experience and qualifications. We have an Operations and Maintenance team that provides a licensed electrician, HVAC specialist, micro examination and process trouble shooting expertise at rates below those of outside contractors. The cost for these qualified individuals is covered under the annual operating

**budget. The facilities have utilized these Woodard & Curran assets extensively through the year to minimize additional subcontractor charges to the Town. They have been proactive in equipment repairs, both routine and capital, as well as implementing new procedures allowing for optimized treatment process. Training was conducted for all department personnel including topics on facility operations, regulatory reporting, administrative functions and safety. The following items highlight the year's activities beyond routine.**

#### **FACILITY UPGRADE:**

**In March of 2009 the Wastewater Treatment Facility received a new NPDES permit for discharging into the Souhegan River. The permit requires the facility to remove new contaminants that the current plant was not originally designed to achieve. Penalty measure can be enforced by the EPA if steps to meet compliance are not carried out. As a result the current Wastewater Treatment plant needs to be upgraded. The project is anticipated to be completed in 2014 and we are currently working with DES and the EPA to comply with all needed requirements.**

**In February, Woodard and Curran, on the Town's behalf, submitted two funding requests through the state stimulus (ARRA) funding program. We were approved for one project in the amount of \$862,000 to begin the initial stage of the facility upgrade. These funds will be used to install a new clarifier at the facility which will be completed in July of 2010. Additional upgrades will be required in the future to meet regulatory compliance mandates.**

#### **REPAIR & MAINTENANCE**

- The new generator at the facility was hard wired into the plant, through an automatic transfer switch. This replaces the original, circa 1974 unit which was not cost effective to repair.**
- A new 4 gas continuous monitor system was installed in the facility wet well. This unit protects employees from being engulfed in toxic fumes that could result in fatalities. This unit was installed and paid for by Woodard and Curran and eliminates the need to use a small inadequate portable unit. The unit and installation costs were \$6,200 and was an OSHA mandate for the ultimate safety of all personnel who may enter the wet well at the facility.**

## **COLLECTION SYSTEM**

The wastewater department has been busy completing a new collection system maintenance plan, as mandated in our new NPDES permit. This plan is an extensive 32 page document, that outlines the Town's plan for maintaining the collection system. When the plan is completed an annual report will need to be submitted to DES to ensure that all work is completed as specified annually. Projects related to this plan include; video inspections of strategic sewer lines to assist in identifying cracked and collapsed piping to reduce the inflow of rain water into the sewer system, collection system cleaning and man hole inspections/repairs.

- Pumped out and cleaned the pump station wet wells, removing significant grease, grit and other non-biodegradable materials which accumulated over time. This greatly extends the life of the pumping equipment.
- A new sewer line jetter was purchased. This unit will be used for collection system maintenance/cleaning and will help better identify problem spots, when capturing video images of the system.

### **Ongoing efforts to reduce inflow & infiltration**

Performed in-house surveys on River and High St. We found a total of 3 sump pumps illegally tied into the system. The residents reconfigured the piping and set-up to discharge on their property.

## **WATER TREATMENT FACILITY & SYSTEMS**

In 2009, Woodard & Curran provided complete Operations and Maintenance of the Water Treatment Facility, two storage tanks, distribution system as well as meter reading and repairs. The Water Treatment personnel sampled for over 95 regulatory contaminants as mandated by both the EPA and NH DES with no violations reported for the year. Many more analyses were performed for process control and assurance measures.

### **STAFFING**

The Water Treatment Facility, distribution system, meter reading and meter repairs are maintained and operated by the following staff.

Note: Additional personnel are utilized when needed and are supplied by Woodard & Curran at no additional cost to the Town.

### **OPERATION & MAINTENANCE**

Woodard & Curran has an extensive support network that allows for expert assistance to address facility problems that may extend past the normal operator level of experience and qualifications. We have an Operations and Maintenance team that provides a licensed electrician, HVAC specialist, micro examination and process troubleshooting expertise at rates below those of outside contractors. The cost for these qualified individuals is covered under the annual operating budget. The facilities have utilized these Woodard & Curran assets extensively through the years to minimize additional subcontractor charges to the Town. They have been proactive in equipment repairs, both routine and capital, as well as implementing new procedures allowing for optimized treatment process. Industry required training was conducted for all department personnel including topics on facility operations, regulatory reporting, administrative functions and safety. The following items highlight the year's activities beyond routine.

## **ADMINISTRATIVE**

- Woodard & Curran assisted the Town by managing all paperwork associated with December 2008 devastating ice storm. There were a total of five LGC claims and one FEMA claim. The combined claims totaled \$105,929. With due diligence and to expedite recovery and repair efforts and to reducing the Town's exposure to potential water and wastewater system emergencies; Woodard and Curran, the contracted operations company for the Town, covered all costs related to this event for six months until which time the Town received funds from the claim submittal and reimbursed Woodard & Curran accordingly. Please note that this was done at no additional charge or mark up.
- In February, Woodard and Curran, on the Town's behalf, submitted two projects for the facility under the stimulus (ARRA) funding provided by the state of New Hampshire. One project was approved for \$125,000; to upgrade the current meter reading network system. The project is scheduled to be completed in March of 2010 and will require that residents are proactive with scheduling of meter replacements to meet the scheduled completion date. The Town's financial obligation per the ARRA funding stipulations will be funded from the water revenue funds.

## **DISTRIBUTION MAINTENANCE**

- Over the course of the last year the BOS have been putting together RFPs for the Adams Hill water tank. One RFP is for the replacement of the tank and the other one is for reconditioning of the old tank.
- Bi-annual Hydrant flushing and annual maintenance (i.e. winterization).
- Replaced 4 residential water meters.
